## EXECUTIVE ORDER NO. 1 OF 2023.

### EXECUTIVE ORDER ON THE PROMOTION OF TRANSPARENCY AND EFFICIENCY IN THE BUSINESS ENVIRONMENT.

WHEREAS, it is the policy of ONDO STATE to create an enabling environment for businesses and entrench measures and strategies aimed at promoting transparency and efficiency;

NOW, THEREFORE, PURSUANT TO THE POWER VESTED IN ME BY SECTION 5 (2) OF THE 1999 CONSTITUTION OF THE FEDERAL REPUBLIC OF NIGERIA, (AS AMENDED), I, HON. LUCKY ORIMISAN AIYEDATIWA, THE EXECUTIVE GOVERNOR OF ONDO STATE HEREBY ORDER AS FOLLOWS:

1. The under listed Ministries, Departments and Agencies (MDAs) of ONDO STATE shall publish on State official website(s) all relevant information on fees, procedures, Services Level Agreements (SLAs), Grievance Redress Mechanism (GRM) for all core business regulatory processes provided by the MDAs.
2. The MDA's shall publish on State official website(s) Advance communication rules of upcoming changes to the information on any of the items in (1) above and such changes shall come into effect only after a minimum of Thirty (30) days after the date of notice of the changes.
3. The MDA's shall provide contact information (telephone number or email address) which must remain functional during working hours.
4. This order is applicable to:

-Application Process & Guidelines for Obtaining Building Permit in Ondo State.
  - b) **Ondo State Ministry of Commerce, Industry and Cooperative Services.**  
-Application process & Guidelines for the Registration of Business Premises.



**c) Ondo State Ministry of Environment**

-Application process and Guidelines for Environmental Impact Assessment (EIA).

**d) Ondo State Signage and Advertisement Agency**

-Application process and Guidelines for Obtaining Signage Permit.

**e) Ministry of Lands and Housing**


